

CHARTERED ACCOUNTANTS (ACA)

Duration - 3/3.5 years (Dependent on exemptions based on educational background)

No. of Exams - 10.5

Cap 1 law is a 0.5 on demand assessment sat ahead of main exams.

Exam Structure

- CAP 1 (4 exams + Law)
- CAP 2 (4 exams)
- FAE (1 Core & 1 Elective)

Flexibility – Structured and no flexibility to alter sitting. Exams sat consecutively over one week timeframe.

Exam sittings – 2 sittings a year. Summer and Autumn. Summer is firm main sitting with Autumn allowance for resits.

Exam Support – Additional house support sessions led by experts.

Lecture commencement – Lectures commence in September/ October each year.

Duration - 3 years

No. of Exams - 13

Exam Structure -

- Applied Knowledge (3 exams)
- Applied Skills (6 exams)
- Strategic Professional (2 Core exams & 2 Electives)

Flexibility – Very flexible. Students do not have to sit an exam at every sitting if circumstances allow. One exam per sitting – dependant on exemptions.

Exam sittings – 4 sittings a year available – March, June, September, December. Please note sitting are dependent on busy periods in a department.

Exam Support – The firm financially supports courses hosted by external providers led by experts + additional support videos.

Lecture commencement -

Dependent on exam sitting. Classes would typically commence 12-13 weeks prior to the exam.

Exam sittings - 2 sittings a year. Summer and Autumn. Summer is firm main sitting with Autumn allowance for resits/late joiners.

Exam Support - In-house exam preparation sessions.

Lecture commencement - Lectures commence in October each year for the Autumn course.
